

TERMS & CONDITIONS FOR AK COLLECTORS FESTIVAL COSPLAY COMPETITION

- All Cosplays (anime, superhero, video games, etc.) permitted in this 3. competition are subject to acceptable public decency and local customs & norms. Props which may function as real weapons or pose danger to the public are strictly prohibited. All props are to be submitted for safety inspection on competition day.
- Contestants are required to check-in in full costume as per online 4. submission photo at AK Information Counter, Ground Floor on 7 May 2017 from 11.00am to 1.00pm.
- Contestants must bring along a photo of their costume as per online 5. submission during check-in.
- Contestants will be judged based on skit, costume creativity and 6. accuracy, pose and judge's bonus.
- During the competition, each contestant will be required to showcase 7. themselve in 3 cosplay posses and offered up to 2 minutes to perform a skit. Each contenstant maybe assisted by up to 2 helpers in their skit. The skits should not contain elements potentially offensive to local society and refrain from issues relating to race, religion or politics.
- Contestants who come in a different costume as per online submission 8. photo will be disqualified.
- By participating in the "AK Collectors Festival Cosplay Competition" all contestants are deemed to have agreed to any and every form of publicity.
